The BIG Aussie Review is a year-long travel program organised and administered by the Promoter, under which the winner(s) and travel companions will undertake a continuous journey throughout Australia starting on the Gold Coast, from 1 July 2026 to 10 July 2027 (Travel Period), staying at accommodation and visiting locations as determined, arranged, or approved by the Promoter. 2. The purpose of the program is for the winner(s), in their capacity as the Promoter's designated travel reviewer(s), to review Australian tourism destinations, attractions, experiences, towns, and BIG4 Holiday Parks and to create related Content for use by the Promoter in connection with The BIG Aussie Review campaign. <p>Overview of Winner Deliverables and Obligations</p> <ol style="list-style-type: none"> 3. By 27 April 2026, the Promoter may arrange to interview Eligible Entrants, and interviews must be completed by 7 May 2026.</p> <p>2. TERMS AND CONDITIONS

1. The Schedule, and any other information on how to enter, form part of these terms and conditions (**Terms and Conditions**).
2. Participation in this promotion is deemed acceptance of these Terms and Conditions.

ENTRIES AND HOW TO ENTER

3. To enter, Eligible Entrants must follow the instructions set out in Item 6 and Item 7 of the Schedule.
4. Incomplete, incorrect, misleading, fraudulent or indecipherable entries will be deemed invalid. The Promoter is not liable for entries, prize claims or correspondence that are misplaced, misdirected, delayed, lost, incomplete, indecipherable or incorrectly submitted. Eligible Entrants must enter in their own name.
5. Directors, officers, management and employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to enter.

WINNER(S) AND PRIZE(S)

6. The winner(s) will be determined as set out in Item 7 of the Schedule.
7. The Caravan and Loan Car must be collected by the winner(s) on their arrival in Gold Coast, Australia at the beginning of the Travel Period as reasonably directed by the Promoter. BEHAVIOUR OF ENTRANTS AND CONDUCT OF THE PROMOTION

14. Eligible Entrants, winner(s) and travel companions must not:
 - (a) engage in any conduct that may jeopardise the fair and proper conduct of this promotion;
 - (b) act in a disruptive, threatening, abusive or harassing manner;

- (c) do anything that may diminish the good name or reputation of the Promoter or any of its related entities or of the agencies or companies associated with this promotion; or
- (d) breach any law.

15. Should a winner or travel companion breach clause 14, the Promoter may, if reasonably required to protect the Promoter's legitimate interests, terminate The Big Aussie Review, and for the avoidance of doubt, the winner(s) will no longer be entitled to the prizes.

16. If this promotion (including The BIG Aussie Review) is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention, fraud or a dispute between joint winners, the Promoter reserves the right, acting reasonably, to the fullest extent permitted by law:

- (a) to disqualify any Eligible Entrant; or
- (b) to modify, suspend, terminate or cancel this promotion (including The BIG Aussie Review), as appropriate.

17. The use of any automated entry software or any other mechanical or electronic means that allows an Eligible Entrant to automatically enter repeatedly is prohibited and will render all entries submitted by that Eligible Entrant invalid.

18. The Promoter reserves the right, at any time, acting reasonably, to:

- (a) verify the validity of entries and Eligible Entrants (including an Eligible Entrant's identity, age and place of residence or other information supplied at the time of entry); and
- (b) disqualify any individual (and all associated entries) who the Promoter has reason to believe has breached any of these Terms and Conditions.

19. Failure by the Promoter to enforce any of its rights does not constitute a waiver of those rights.

CONTENT

20. Eligible Entrants agree that they are fully responsible for any materials they submit via this promotion or in the course of completing The BIG Aussie Review as a winner(s) of the promotion including but not limited to comments, recordings and images (**Content**). The Promoter shall not be liable in any way for such Content, to the full extent permitted by law. The Promoter may remove or decline to publish any Content without notice for any reason whatsoever.

21. Eligible Entrants warrant and agree that:

- (a) they will not submit any Content that is unlawful or fraudulent, or that a reasonable person would consider to be in breach of any intellectual property, privacy, publicity or other rights, defamatory, obscene, derogatory, pornographic, sexually inappropriate, violent, abusive, harassing, threatening, objectionable with respect to race, religion, origin or gender, not suitable for children aged under 15, or otherwise unsuitable for publication;
- (b) the Content shall not contain viruses or cause injury or harm to any person or entity;
- (c) they will obtain prior consent from any person or from the owner(s) of any property that appears in their Content;
- (d) the Content is the original artistic or literary work of the Eligible Entrant that does not infringe the rights of any third party;
- (e) they consent to any use of the Content by the promoter and its affiliates and sub-licensees, which may otherwise infringe the Content creator's/creators' moral rights pursuant to the Copyright Act 1968 (Cth) and warrant that they have the full authority to grant these rights; and
- (f) they will comply with all applicable laws and regulations, including without limitation, those governing copyright, content, defamation, privacy, publicity and the access or use of others' computer or communication systems.

22. Without limiting any other terms herein, the Eligible Entrant agrees to indemnify the Promoter for any breach of the warranties listed in clause 21.

23. As a condition of entering this promotion, each Eligible Entrant licenses and grants the Promoter, its affiliates, sub-licensees and third party sponsors of The BIG Aussie Review a non-exclusive,

royalty-free, perpetual, worldwide, irrevocable, and sub-licensable right to use, reproduce, modify, adapt, publish and display the Content for any purpose, including but not limited to future promotional, marketing or publicity purposes, in any media, without compensation, restriction on use, attribution or liability.

24. Eligible Entrants consent to the Promoter using their name, likeness, image and/or voice in the event they are a winner(s) (including photograph, film and/or recording of the same) in any media for an unlimited period without remuneration for the purpose of promoting this promotion (including any outcome) and promoting the business of the Promoter. The Eligible Entrant agrees to participate in all reasonable promotion activities in relation to the prize as requested by the Promoter and its agents and sign any additional documents reasonably required by the Promoter to give effect to this condition.

25. As a condition of participating in a prize, a winner(s) must procure that the travel companions also consent to the Promoter using their name, likeness, image and/or voice (including photograph, film and/or recording of the same) in any media for an unlimited period without remuneration for the purpose of promoting this promotion (including any outcome) and promoting the business of the Promoter. A winner(s) must procure that the travel companions agree to participate in all reasonable promotion activities in relation to the prize as requested by the Promoter and its agents and sign any additional documents reasonably required by the Promoter to give effect to this condition.

DISPUTES

26. If there is a dispute concerning the conduct of this promotion (including as to the identity of an Eligible Entrant), between joint winners, or otherwise in respect to receiving a prize or completing The BIG Aussie Review, the Promoter will consider the Eligible Entrant's grievances however reserves the right to resolve the dispute in the manner it determines most appropriate, acting reasonably. 27. Nothing in these Terms and Conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act (Cth) or similar consumer protection laws in the States and Territories of Australia (**Non-Excludable Guarantees**).

28. The Promoter is not responsible for any tax implications arising from the winning of prizes. Winners should seek independent financial advice. If for GST purposes this promotion results in any supply being made for non-monetary consideration, Eligible Entrants must follow the Australian Taxation Office's stated view that where the parties are at arm's length, goods and services exchanged are of equal GST inclusive market values.

29.
