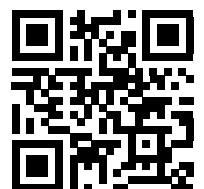

Eligibility Criteria

Redemption of the 2026 Ford Partner Members Offer is subject to certain Terms and Conditions as set out below.

As BIG4 Holiday Parks Perks+ memberships are valid for 24 months, members will need to show that the expiry date is valid and meets the minimum 3 month waiting period by the expiry date being no more than 21 months from the time of purchasing the vehicle. The two methods Perks+ members can prove their membership are:

- Perks+ digital membership card (Apple Wallet or Android Google Wallet) or
- Perks+ membership on <https://www.big4.com.au/> (login to account).

Further support for BIG4 Members:

- If a Perks+ member cannot remember login details, they can 'reset a new password' using their login credentials to access their membership details.
- If the Perks+ member is showing more than 21 months on their membership, but they say they have been a member for longer than 3 months, it means they have recently renewed an ongoing membership. The member can show their Perks+ renewal receipt email as proof of their 24+ month membership tenure.

Terms and Conditions

Redemption of the 2026 Ford Partner Members Offer is subject to certain Terms and Conditions as set out below.

1. This Offer is only available to paid-up, current members of BIG4 Holiday Parks. Members must present complete, original, and unaltered proof of membership at participating Ford Dealers at the time of ordering a new Ford vehicle.
2. To be eligible for this Offer, the customer must have held a valid BIG4 Holiday Parks Perks+ membership for a minimum period of three (3) months prior to redemption.
3. One eligible membership = one claim.
4. Memberships are not to be purchased by dealers on behalf of customers.
5. The Offer commences on 10th April and expires 31st December 2026 (Offer Period).
6. Eligible members can purchase a maximum total of two (2) new Ford vehicles under this program during the offer period. Demonstrator vehicles are ineligible vehicles.
7. This Offer is limited to retail customers and Blue Fleet customers only operating as a sole trader.
8. The new Ford vehicle(s) purchased under the 2026 Ford Partner Members Offer must be registered in the member's name.
9. The Offer may be combined with other offers or promotions in the market run by Ford provided that the other offer or promotion explicitly permits combination with additional offers or promotions such as this Offer. However, the offer cannot be used in connection with either:
 - (a) Privilege Club Pricing (Privilege Club Pricing is a vehicle discount program available only to Ford Employees and Retirees and their eligible relatives through authorised Ford Dealerships); or
 - (b) Any other member or employee offer, including offers from other participating partner organisations within this program. A customer is only eligible to redeem one member offer per vehicle purchase, regardless of membership in multiple partner organisations.
